

CORRELSENSE INC.
SHAREPATH AS A SERVICE CLICKWRAP LICENSE AGREEMENT

This is an agreement ("Agreement") between you (a single entity), the user of a hosted version of the Software, and Correlsense Inc. ("Correlsense"). BY ACCESSING OR OTHERWISE USING ANY PORTION OF THE SOFTWARE, OR BY CHECKING THE "I AGREE TO THE TERMS AND CONDITIONS" BOX DURING REGISTRATION, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT ACCESS OR OTHERWISE USE THE SOFTWARE.

1. Definitions. For the purpose of this Agreement: "Documentation" means the instructions and explanatory material (if any) provided with the Software in printed or electronic form; "Software" means the beta version of the Correlsense SharePath software as a hosted application, including the downloadable "Agents", which are deployed on-premise and submit data to the hosted application.

2. Proprietary Rights. The Software is owned by Correlsense and its structure, organization, and code (including without limitation source code) are the valuable trade secrets of Correlsense. Correlsense is the sole and exclusive owner of all right, title, and interest in and to the Software, including any and all developments, modifications, enhancements, and improvements made thereto (including any and all customization of the Software). The license set forth in this Agreement is not an assignment of intellectual property rights in the Software. ALL RIGHTS TO THE SOFTWARE NOT EXPRESSLY GRANTED HEREIN ARE RESERVED BY CORRELSLSENSE OR ITS SUPPLIERS.

3. Grant of Limited License. Provided that you comply with the terms and conditions of this Agreement, Correlsense grants to you a non-exclusive, non-transferable limited license to access and use the Software and the Documentation, subject to the following restrictions:

(a) Limited Number of Agents. This license of access and use is limited to the number of Agents set forth in the SharePath SAAS Service Description, which may be amended from time to time.

(b) Access and Use of Software. The license acquired by you under this Agreement is solely to access and use the Software as a hosted application for your own internal business purposes in accordance with the Documentation. You may not (i) prepare derivative works based on the Software, (ii) reproduce the Software, (iii) sell, assign, transfer, license, sublicense, publish, disclose, display, or otherwise make available the Software or copies thereof in any form whatsoever to any third parties (including but not limited to your own customers, suppliers, partners, or any related entities) or (iv) use the Software for any third party's data processing, computing, or other needs. You may not modify, translate, reverse engineer, decompile, or disassemble, the Software. You may not remove any proprietary notices, labels, or marks on the Software and any permitted copies thereof must contain such notices, labels, or marks.

4. DISCLAIMER OF WARRANTIES. THE SOFTWARE IS LICENSED “AS IS”. CORRELSense AND ITS SUPPLIERS AND AUTHORIZED DISTRIBUTORS MAKE AND YOU RECEIVE NO WARRANTIES OR CONDITIONS, EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, AND CORRELSense AND ITS SUPPLIERS AND AUTHORIZED DISTRIBUTORS SPECIFICALLY DISCLAIM ANY IMPLIED WARRANTIES OF MERCHANTABILITY, OF LACK OF VIRUSES, AND OF FITNESS FOR A PARTICULAR PURPOSE. CORRELSense AND ITS SUPPLIERS AND AUTHORIZED DISTRIBUTORS DO NOT WARRANT (A) THE AVAILABILITY OF THE HOSTED APPLICATION OR OF YOUR DATA, (B) THE SECURITY OF YOUR DATA, OR (C) THAT THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE. YOU ASSUME THE RESPONSIBILITY FOR THE SELECTION OF THE PROGRAM AND HARDWARE TO ACHIEVE YOUR INTENDED RESULTS AND FOR THE USE AND RESULTS OBTAINED FROM THE PROGRAM.

5. LIMITATION OF LIABILITY. IN NO EVENT WILL CORRELSense OR ITS SUPPLIERS OR AUTHORIZED DISTRIBUTORS BE LIABLE FOR ANY LOSS OF DATA, LOSS OF INCOME, LOSS OF OPPORTUNITY OR PROFITS, OR COST OF RECOVERY OR FOR ANY OTHER SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR INDIRECT DAMAGES ARISING FROM THE USE OF THE SOFTWARE, OR THE ACCOMPANYING DOCUMENTATION, HOWEVER CAUSED AND ON ANY THEORY OF LIABILITY. THIS LIMITATION WILL APPLY EVEN IF CORRELSense, ITS SUPPLIERS, OR AUTHORIZED DISTRIBUTORS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. IN NO EVENT SHALL CORRELSense'S LIABILITY EXCEED THE AMOUNT PAID FOR THE LICENSED SOFTWARE AT ISSUE. YOU ACKNOWLEDGE THAT THE LICENSE FEE REFLECTS THIS ALLOCATION OF RISK.

6. Traffic Monitoring and Aggregated Data. CorrelSense shall be permitted (a) to monitor your traffic and present the information on a dedicated dashboard, and (b) to aggregate data relating to your use of the Software with data relating to other users of the Software and to use such aggregated data in connection with the promotion and marketing of the Software, provided (i) CorrelSense shall not use nor disclose any of your confidential information for such purpose and (ii) you are not referenced or otherwise alluded to as a source of the aggregated data.

7. Term and Termination. This Agreement is effective until terminated. You may terminate this Agreement at any time by providing CorrelSense with written notice of termination. CorrelSense may terminate this Agreement and your access to the Software at any time. Unauthorized reproduction or modification of the Software or of the Documentation, failure to make any payment for the Software when due, or other material failure to comply with the terms and conditions of this Agreement will result in automatic termination of this license and CorrelSense will have such other remedies as are available under law. Upon termination of this Agreement, the license granted herein will terminate and you must immediately cease using the Software and destroy the Documentation, and provide CorrelSense with written certification of such destruction.

8. Advertising. You consent to Correlsense's inclusion of your name and logo on Correlsense's website and in its marketing materials, identifying you as a user of the Software. You also consent to Correlsense including your name and logo in a press release favorably publicizing your selection of the Software. At any time, you may request in writing that Correlsense cease using your name and logo, and Correlsense shall comply with such request within seven (7) days of receipt.

9. Miscellaneous. This Agreement represents the complete agreement concerning the license between Correlsense and you for the Software, except if you have executed a software license agreement with Correlsense, in which case the terms of the signed software license agreement shall govern. This Agreement may be amended only by a writing executed by both parties. If any provision of this Agreement is held to be unenforceable for any reason, such provision shall be amended only to the extent necessary to make it enforceable. This Agreement is to be construed in accordance with and governed by the internal laws of the State of New York without giving effect to any choice of law rule that would cause the application of the laws of any jurisdiction other than the internal laws of the State of New York to the rights and duties of the parties. The parties hereto consent to the personal and exclusive jurisdiction and venue of the courts of New York, NY.
